Attached you will find the application for Newton Parkes for the open Board Director position on the Temecula-Elsinore-Anza-Murrieta Resource Conservation District recently vacated by Jack Fleming due to illness.

During a Special Board Meeting convened on August 5, 2019, our Directors unanimously voted to support Newton Parkes, who is already an Associate Director on our Board, for the open position. Mr. Parkes has been instrumental in moving our Board forward by volunteering to take on several projects with our District and has jumped in with both feet to continue our good work.

In particular, we have appointed Newt as our point person and liaison for our Homeless Monitoring and Restoration projects. He will be the coordinator for the pilot projects regarding the Homeless we presently have with Riverside County Flood Control. He has already met with the Homeless Task Forces of Temecula, Murrieta and Lake Elsinore and is looking forward to seeing how we can be an asset to you in working closely with your staff and your Homeless projects in District 3. Dear Colleagues,

As we wrote in our update last month, Senate Bill 253 (Dodd) passed through the California Senate floor with unanimous consent and is making its way through the Assembly. It will be heard in the Assembly Agriculture Committee on July 3 and the Assembly Natural Resources Committee on July 8.

If you haven't been following the news about SB 253, a quick brush-up is below:

*CARCD and The Nature Conservancy have co-sponsored SB 253 with the goal of providing an additional source of funding to participating RCDs for the benefit of conservation efforts in California. If passed, SB 253 would create the Environmental Farming Incentive Program (EFIP), a state analog to NRCS' Environmental Quality Incentives Program. The program, administered under the California Department of Food and Agriculture, would provide funding for on-farm conservation practices and technical assistance to support these efforts. You can find [SB 253's fact sheet here](#).*

CARCD and our legislative consultants Pacific Policy Group are currently working with the Nature Conservancy and Senator Dodd's office on **amending the bill to explicitly determine RCDs as the technical assistance providers**. Language in the amendment will allow for UC Cooperative Extension and nonprofits to provide technical assistance, but only in locations that a Resource Conservation District is unable to provide the service.

The bill enjoys support from a diverse coalition of environmental groups and the agricultural community, including Cattlemen's Association, the Rice Commission, the Northern California Water Association, Audubon California, Sustainable Conservation and more!

We are excited about the potential for this bill to transform on-farm conservation efforts in California, and to raise the visibility of RCDs as major technical service providers. If you haven't done so already, please be sure to send us your RCD's letter of support. 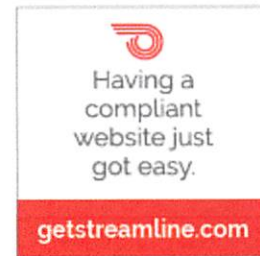

## Pollinator-Friendly Urban Spaces and Working Lands

Many pollinator species are seeing alarming population declines in California, and habitat loss is a key contributor to the problem. In urban areas, population growth is leading to an increased need for land that can accommodate infrastructure like schools, shopping centers, and residential homes. Land and open space that previously supported natural habitat for pollinators is constantly being converted to support urban growth and industrial development. While urban areas can be a stressor for pollinator species, it also represents an opportunity for conservation and public education. RCDs

already work with schools, urban parks, and landscapes/gardens to bring conservation Best Management Practices, educational resources, and technical assistance to diverse communities in urban areas. RCDs also maintain partnerships with local public and private entities in control of properties in and adjacent to urban/wildland interfaces where pollinator support is critical.

## Program Highlights Civic Engagement

### Civic Engagement for Our Water Future

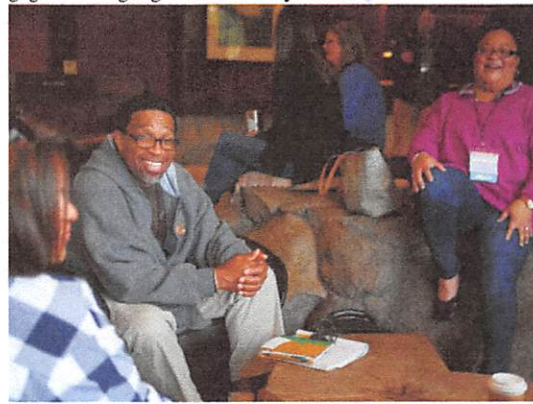
